5. Reports/Updates	Point in Time Count took place January 28 with 60+	
PIT Update	volunteers. Everything went smoothly and, with the help of HOT outreach, we tried to focus on some new locations. Unofficial results indicate an increase in homelessness of approximately 14%, which is probably due equally to more intensive outreach and actual increase in homeless persons. An incr4ease of 29 homeless youth was seen, but we are not seeing the huge increase in number of homeless students as the state is seeing. Final report is expected in April/May. Feel good: A man who had been living around the Health Department for a good while approached Barbara to let her know he'd found housing after extensive work by the HOT team to get him services, and one homeless man who had been "living" in our Girard Street doorways at night stowed his worldly possessions in our bushes during the day when he went to work. One day, our yard crew removed all his belongings and placed them under a tree, although it was about to rain. We beckoned our Homeless Outreach Team to help us identify the owner of the goods, who they knew. They

5.	Reports/Updates PIT update (con't)	 Agreed to pick up his belongings and wait for his return "home" from work. They wanted to be sure his personal property was dry and in good condition because his housing was becoming available the very next day. Flyer provided for the "Homeless in Bellingham" film project. Screening and discussion will occur February 24 at the Bellingham Public Library. The films have been shown at neighborhood associations. Goal for season two was 10,000 viewers and that goal has been surpassed. Entire series is available on the Opportunity Council's Homeless Service Center website. Council will be informed of the series. Times and locations for the Human Rights Film Festival are also available on Opportunity Council's website http://www.whatcomhsc.org/ 	
•	Legislative update	• Hope is for ten million more in the state housing trust fund. CHG funding has been a moving target. Commerce is seeking to allocate \$11 million. Evictions recording legislation is being considered. Fair Tenant Screening, to make screening reports portable, died in Senate. Source of income discrimination, which disallows housing discrimination based on source of income, is moving along. A request for \$300 million from the state's rainy day fund for homelessness might not pass, but press exposure is good by creating a buzz. City Council unanimously approved the Aloha project with 154 units for seniors, families, formerly homeless and businesses that operate into night hours for a nighttime presence. Hope for a three year time frame.	
•	Planning Commission City of Bellingham Homeless Efforts	 Nothing to report Tara Sundin provided update. It is a high priority of the mayor to bring resources to Bellingham and Community Development is looking at housing options. Lighthouse might partner with the city for a low barrier shelter. A lease situation would be ideal; siting is an issue. Also looking at Peace Health to partner from a point of savings
