Check In: What is Role of Food System Committee

Discussion of things the Food System Committee can do as needs in the food system becomes apparent:

- Make recommendations to County Council through motions and formal language.
- Hold public hearings.
- Work on policy documents.
- Gather information and research food system needs.

Members agreed they want to send food system recommendations to the County Council as soon as possible.

The group briefly brainstormed ideas, including non-emergency food access, land allocation, and laborers.

How COVID is Impacting the Food System from Laura Ridenour

The Whatcom Food Network had a Spring Forum on May 15th which was attended by 65 people. Laura was a facilitator. They discussed gaps, innovations, and silver linings in the food system due to COVID in Zoom breakout rooms. Common topics that arose included:

- Systemic challenges- COVID has exacerbated some of the breaks in the food system.
- Food access concerns.
- Information lag behind realities on the ground.
- How to identify who needs support.
- Urban vs rural access to resources.
- How to get involved and volunteer.
- Sustaining support for local food.
- Concern about winter food storages.
- Restaurants need business support.
- Food production and processing- bulk items are going to waste.
- Labor shortage- lack of workers and safe housing for workers.
- Revelation of inequities in the labor industry.
- Increased need for packaging for food safety.
- The need for more places to grow their own food.
- Justice, equity, and diversity needs in the food system.
- Looking to California and Mexico to see issues they are already seeing as a predictor of what we will see.

How COVID is impacting the Food System from FSC Reps

The group echoed some of the issues above and highlighted the need for immediate recommendations for laborers and food security.

Review of State Food Policy Forum Recommendations

June 25th, the State Food Policy Forum will vote on an Implementation document, which outlines immediate recommendations for the State Legislature. The FPF is consensus based. If any member disagrees with a measure and doesn't stand aside, it won't go forward.

The group will assess State Food Policy Forum recommendations for consideration.

Next Steps

The group agreed to make a list (2-3 pages) of recommendations for the Whatcom County Council. The group will meet next week to discuss potential recommendations.

Committee staff will receive policy ideas by Friday. Staff will separate budget vs non-budget ideas.

Some organizations to glean data from include Sustainable Connections, Whatcom Unified Command's Food Security Task Force, and the Port's economic development workgroup.
