WHEREAS, interim changes to fees are enacted by Executive Order until incorporated into the Unified Fee Schedule Ordinance, and


WHEREAS, on December 4, 2018, the County Council adopted Ordinance 2018-076 authorized the **2019 Whatcom County Unified Fee Schedule (UFS)**, and

WHEREAS, sixty-five currently posted Executive Orders have been replaced by the 2019 and prior UFS Ordinances, and

WHEREAS, the present Administration desires to leave a clear policy legacy for the incoming County Executive,

NOW, THEREFORE, By virtue of the power vested in me by the Home Rule Charter for Whatcom County, I hereby rescind all Executive Orders related to Fee Schedules issued prior to December 4, 2018 because they have been adopted by Ordinance of the County Council.
