After carefully considering the needs of our schools and respecting our taxpayers, our school board passed a resolution requesting a replacement levy that incrementally increases the levy rate over 4 years. Voting yes to replace the levy is a vote to continue the quality education provided to all students in Nooksack Valley.

The Board of Fire Commissioners of Whatcom County Fire Protection District 8 adopted Resolution No. 2019-03 concerning a proposition to finance maintenance and operation expenses. This proposition would authorize the District to levy an excess property tax on all taxable property within the District for four years to be used for maintenance and operations, improving and repairing fire district facilities, and to maintain the current level of fire and emergency medical services. The levy amount shall be as follows:

Explanatory Statement

Whatcom County Fire Protection District 8 requests approval of a four year maintenance and operations property tax levy. As a result of declining tax revenues and increasing costs, the District's regular tax levy is no longer adequate to continue providing fire and emergency services at existing levels of service or to make necessary facility improvements. By spreading costs over four years, the district is able to limit this levy to approximately 87 cents per thousand dollars of assessed valuation. If approved, the law prohibits any additional maintenance and operations tax levies for this four-year period.

Statement For

Please vote yes to renew Fire District 8's M&O levy. This levy provides essential funding to ensure the staffing of the District's fire stations 24 hours a day, seven days a week. In addition to providing funding for staffing, the renewed levy will help to replace the departments aging fleet and provide some money for facility upgrades.

The two fire stations (Bennett Dr. and MacKenzie Rd) are both over 50 years old and are in need significant upgrades. The District's fleet has 2 engines that need refurbishment and an ambulance that needs replacement.

The District has worked hard to keep costs down, but the reality is that expenses have grown at 3% per year while tax revenues are limited to 1 % increases. The District started the M&O Levy in 2016 as a way to help fill this gap.

The new levy returns the tax rate to \$1.97 per thousand of assessed value that was approved in 2016. This represents a 27-cent increase over 2019. The owner of a \$400,000 home would see their taxes increase by only \$108 a year or \$9 a month. Please vote yes to continue this critical funding into the future.
